**MAWSON RESOURCES ENGAGES PUBLIC RELATIONS CONSULTANT IN EUROPE**

**Vancouver, Canada – Mawson Resources Limited ("Mawson") TSXv – MAW; Frankfurt – MRY.** The Company is pleased to announce that it has entered into a consulting agreement in Europe. The Consultant shall provide public relations advisory services to the Company inclusive, but not limited to, completing a comprehensive communications program to introduce the Company to German-speaking financial audiences of Europe. In consideration for the services, the Company will pay to Pascal Geraths Gesellschaft Für Presse - Und Öffentlichkeitsarbeit MBH Company No. 261358A (the "Consultant") a fee in the amount of 7,500 Euros per month and reimburse all reasonable expenses.
