MAWSON ANNOUNCES RESULTS OF ANNUAL GENERAL MEETING OF SHAREHOLDERS

Vancouver, Canada – <u>Mawson Resources Limited</u> ("Mawson") (TSX: MAW) (Frankfurt: MXR) (PINKSHEETS: MWSNF) announces the voting results from the Company's Annual General Meeting of Shareholders held on Wednesday, November 15, 2017 (the "Meeting"). A total of 58,200,290 common shares were voted, representing 55.27% of the Company's issued and outstanding common shares. Shareholders voted in favor of setting the number of directors at seven (7) and for the re-election of all director nominees.

The Board of Directors also appointed Messrs. Henstridge, Maclean and Saxon as members of the Company's Audit Committee.
